BY ORDINARY MEMBERS**


We refer to our [Circular No. 161/2020](#) whereby Selangor, Kuala Lumpur and Putrajaya will be placed under the Conditional Movement Control Order (CMCO) from 14 to 27 October 2020. In the Standard Operating Procedures (SOPs) of the CMCO, the government authorities have said that meetings should be carried out via video conference and physical meetings are not recommended. In the interest of members' health and well-being, the Central Committee of MPMA has decided to **postpone its 53rd Annual General Meeting (AGM)** (which was originally scheduled on 20 October 2020) to a virtual AGM (*details of the virtual meeting will be provided later*).
