EXTENSION OF SOSCO SCREENING PROGRAMME

Reference is made to the [FAQ ON PROGRAM SARINGAN PRIHATIN](#) released on 21 October 2020 following the [ANNOUNCEMENT BY THE MINISTRY OF HUMAN RESOURCES, MALAYSIA](#) on 21 October 2020.

Highlights of the FAQ are as follows:

- The screening programme is offered to all SOSCO contributing employees including foreign workers for companies that fall under the Conditional Movement Control Order (CMCO) namely Sabah, Selangor, Federal Territory of Kuala Lumpur, Putrajaya and Federal Territory of Labuan.
- SOSCO contributors that have previously done the screening can retake the screening.
- The Program Saringan Prihatin (PSP) will be offered for employers only via Subsidi Saringan Prihatin or through service panels appointed by SOCSO.
- Employers using the Subsidi Saringan Prihatin can opt for the screening process to be carried out at lab other than SOCSO's service panels. Employers must bear the cost of screening first and claim the subsidy up to RM150.00 from PERKESO after the screening is done. Application for the PSP Covid-19 screening can be done via <https://psp.perkeso.gov.my> by producing the receipts issued for the screening.
- The screening carried out under the SOSCO appointed service panels can be done by making an appointment and producing complete details using [Lampiran 1](#). Employees can review the list of service panels via <https://psp.perkeso.gov.my/direktori-panel-perkhidmatan.html>. The screening process can also be done at the work premises accordance the SOPs set by the Ministry of Health (MOH).
- The results of SOSCO's PSP will be notified through email as per details provided in Lampiran 1 for screening done using SOSCO's appointed service panels. For screening done under the Subsidi Saringan Prihatin, employers need to contact the clinic or hospital to obtain the results.
- The results of SOCSO's PSP are confidential and will be made known only to employees, service providers and SOCSO only. However, employees can notify their respective employers of the results. The results will of SOSCO's PSP also be notified thru email that was provided in Lampiran 1.
- The screening is only for SOSCO Contributors under the Employees' Social Security Act 1969.
